Hello MCB Mailbox,

Just wanted to share this promotional email that was received to my inbox. It highlights the availability of THC Distillate as a bulk material or ingredient that is available on "grey" markets. This promotion is advertised as "Cart Ready".

At the cost of \$1,350 per Liter, this translates to \$613 per pound or ~\$1.35 per g. These costs highlight the enormous financial incentive for bad actors to introduce these types of goods "as an ingredient" into their production workflow to aid in producing higher yields and recoveries. Equally troubling, is the fact that introducing THC distillate into a manufacturing production batch is untaxed, as it skips the cultivation to manufacturing transfer levy.

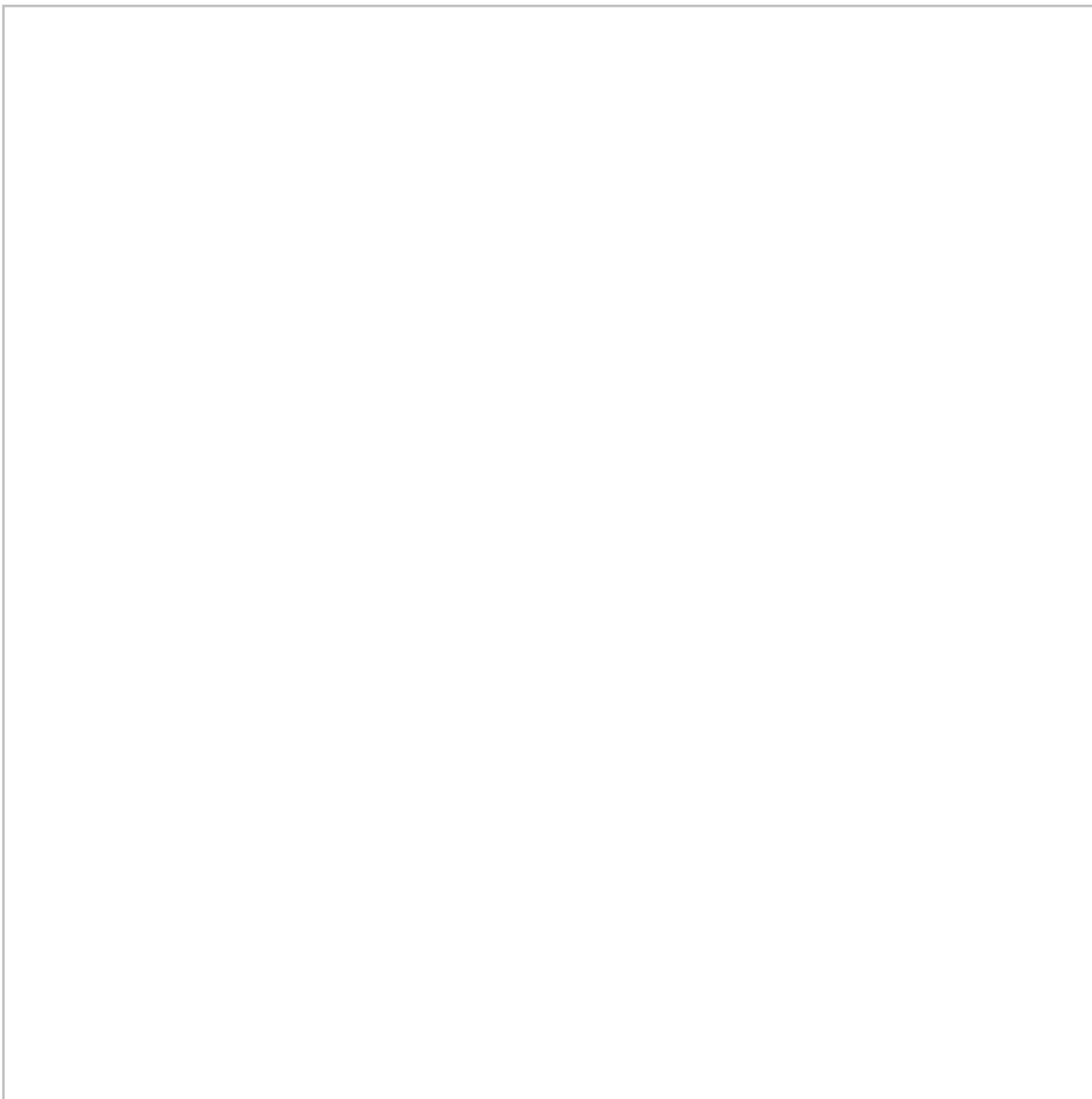

Dear Members of the Marijuana Control Board,

My name is Joseph Stolz. I'm a longtime participant in Alaska's cannabis industry, an advocate for responsible regulation, and a father who believes in building a safer, smarter future for our communities.

I'm reaching out to share an idea that aligns with existing alcohol policy: creating a legal framework for licensed, outdoor cannabis consumption areas (similar to beer gardens.) Modeled after Alaska's Title 4 regulations and inspired by California's cannabis event licensing, this approach would support economic development, tourism, and public safety by providing clear guidelines for social use in controlled environments.

I've drafted a bill concept that adapts Alaska's current alcohol statutes to cannabis, and I'd love the opportunity to share it with MCB and get your thoughts.

## **DRAFT BILL FOR OFF - SITE CONSUMPTION**

**Title:** Cannabis Off-Site Consumption Permit Act

**Purpose:** To establish a permitting system for temporary off-site cannabis consumption, modeled after existing caterer permits for alcohol, enabling licensed marijuana retailers to responsibly sell and serve cannabis at public or private events.

---

### **SECTION 1. OFF-SITE CONSUMPTION PERMIT CREATED**

- (a) The Alcohol & Marijuana Control Office (AMCO) shall issue Off-Site Consumption Permits to qualified marijuana retail license holders for the purpose of conducting temporary cannabis consumption events at locations other than their licensed premises.
  - (b) A permit shall authorize on-site consumption of marijuana by adults aged 21 or older at the specified event location during permitted hours.
  - (c) Each permit is valid for a single event for a specific date or range of dates not to exceed 5 consecutive calendar days.
  - (d) No more than five (5) Off-Site Consumption Permits shall be issued to any license holder per calendar year.

### **SECTION 2. APPLICATION REQUIREMENTS**

- (a) Applications must be submitted at least three (3) business days in advance of the proposed event.
  - (b) Applicants must submit:
    - 1. A site plan showing the secured designated consumption area;
    - 2. A security and crowd control plan;
    - 3. Proof of active retail marijuana license;
    - 4. Written approval from local law enforcement;
    - 5. Proof of local government compliance or approval;
    - 6. Certificate of insurance;
    - 7. Names of all vendors and employees working under the permit;
    - 8. Proof of completed marijuana handler training for all event staff.

### **SECTION 3. ON-SITE OPERATING CONDITIONS**

(a) The permitted event must:

1. Be enclosed or otherwise physically secured to restrict access;
2. Limit entry to persons 21 years or older with valid ID;
3. Display signage indicating it is a cannabis consumption area;
4. Display required retail disclaimer and warning signage;
5. Prohibit entry with outside cannabis products;
6. Prohibit removal of cannabis from the site;
7. Ensure compliance with state and local nuisance and safety laws.

(b) Only prepackaged, tested cannabis products may be sold or distributed.

(c) Smoking and vaping may occur only in outdoor or well-ventilated areas compliant with state and local clean air laws.

(d) Permitted licensee must comply with state approved track and trace requirements.

---

### **SECTION 4. POST-EVENT REQUIREMENTS**

(a) The permit holder shall surrender the permit to AMCO within forty-eight (48) hours of its expiration.

(b) A post-event incident and compliance report must be submitted within ten (10) days.

---

### **SECTION 5. PENALTIES & ENFORCEMENT**

(a) Failure to comply with these regulations may result in:

1. Revocation of future permit eligibility;
2. Fines or suspension of retail license;
3. Criminal referral for unlicensed activity.
4. Suspension or revocation of Marijuana Handler Permit.

(b) AMCO may delegate enforcement to local authorities.

---

### **SECTION 6. DEFINITIONS**

"Off-Site Consumption Permit" means a temporary permit issued to a licensed marijuana retail operator to allow public or private cannabis consumption at an event location away from their licensed premises.

"Designated Consumption Area" means a physically secured and clearly marked section of an event space where cannabis use is permitted.

"Marijuana Handler Training" means AMCO-approved training required for any person serving, supervising, or monitoring cannabis use at the permitted event
