Failure to respond may result in additional enforcement action by AMCO or the Marijuana Control Board.

To the Director of the Marijuana Control Board Mr. Kevin Richards,

We received a Notice of Violation on 7/29/2025 for allegedly selling over one oz of flower to one person. However, we did not sell it to one person; we sold it to two different people. Which clearly shows on the receipts and verified verbally by our customers when approached by officers Linger and Hamilton.

The regulations clearly state:

#### 3 AAC 306.355. Limit on quantity sold.

(a) A retail marijuana store may not sell to any one person per day (1) more than one ounce of usable marijuana; (2) more than seven grams of marijuana concentrate for inhalation; or (3) more than 5,600 milligrams of THC in combined sales of marijuana and marijuana products.

Due to this we feel this violation is not warranted as we did not violate any regulation.

There is no regulation that states the limit on quantity sold is based on who pays for it. Which is what the enforcement officers told me was the basis of the entire violation.

### We would like to request an informal conference with the director under 3 AAC 306.844.

Please also redact the names of our customers on the receipts attached to NOV before making public on the agenda for the MCB meeting.
