Chair Bailey Stuart opens public comments at 1:02pm. Chair Bailey Stuart informs the public that the Department of Law has closed all open regulations projects, so they are open to speak on all regulations.

Trevor Haynes – *President of AMIA, speaks on behalf of AMIA requesting:*

- 1. A temporary pause for 6–12 months on issuing new marijuana licenses to allow AMCO to stabilize core functions.*
- 2. Issuance of a statewide advisory on intoxicating hemp to clearly communicate Alaska's zero-THC hemp policy.*

He emphasizes that AMIA supports the hemp industry and seeks clarity, not restriction. Lacy Wilcox asks whether the pause would apply to all license types. Mr. Hayes responds that it is not specific to any license type.

Joe Stoltz, *speaking as an individual, discusses imported converted hemp isolate and states that while the federal government closed the loophole, the state has not issued an advisory. He discusses consumption issues and the need for controlled outdoor consumption spaces and a modernized tax system.*

Johnny Furlong *speaks regarding actions involving Next Level Labs and other companies, stating that hemp conversion falls under the Department of Natural Resources, corrective action occurred, and AMCO jurisdiction was exceeded. He expresses concern about perceived industry protectionism.*

Nick Miller, Alaska Buds licensee and former Board Chair, expresses frustration with licensing delays, renewal timelines, and lack of value for fees paid. He states enforcement should be consistent and focused on accountability.

Terry Zell, bad gramm3r licensee, suggests increasing meeting frequency to speed processes.

Tasha Grossl, Lady Gray licensee, supports a pause in license renewals and asks about rumored white-label hemp-derived products and enforcement clarification on in-house manufacturing.

Megan Moody, supports prior comments and requests regulatory consideration to allow children under 21 on licensed premises under certain circumstances.

There is discussion regarding infused pre-rolls being produced under a concentrate manufacturing license. Attorney Jana Weltzin states that the process uses only marijuana—flower and concentrate with no ingredients taken but the plant. She clarifies that no other substances are added.

Director Kevin Richard seeks clarification regarding the Board’s intent for Concentrate facilities under 3 AAC 306.505. Attorney Weltzin cites the definition under 17 AAC 38.900(11), stating that concentrate means resin, oil, wax, or any substance produced by extracting or isolating cannabinoids, THC, or other compounds from marijuana or harvested marijuana material.

Director Richard recites 17 AAC 38.900(15) and asks whether an infused pre-roll containing marijuana concentrate qualifies as a concentrate. Attorney Weltzin references historical discussions supporting this interpretation. The Board indicates that this is not a public health issue and acknowledges a potential change in precedence.
