This Operating Agreement (the "Agreement") of Rik in Alaska LLC, an Alaska Limited Liability Company (the "Company"), is entered into as of the date of signature below, by Erikah Ojaniemi as the sole member (the "Member").

ARTICLE I: COMPANY FORMATION

- **1.1 Formation:** The Member has formed a Limited Liability Company subject to the provisions of the Alaska Revised Limited Liability Company Act (Title 10, Chapter 50 of the Alaska Statutes).
- **1.2 Name:** The name of the Company is Rik in Alaska LLC.
- **1.3 Principal Office:** The principal place of business of the Company shall be located in Healy, Alaska, or at such other locations as the Member may determine from time to time.
- **1.4 Registered Agent:** The name and address of the Company's initial registered agent shall be as stated in the Articles of Organization filed with the State of Alaska.

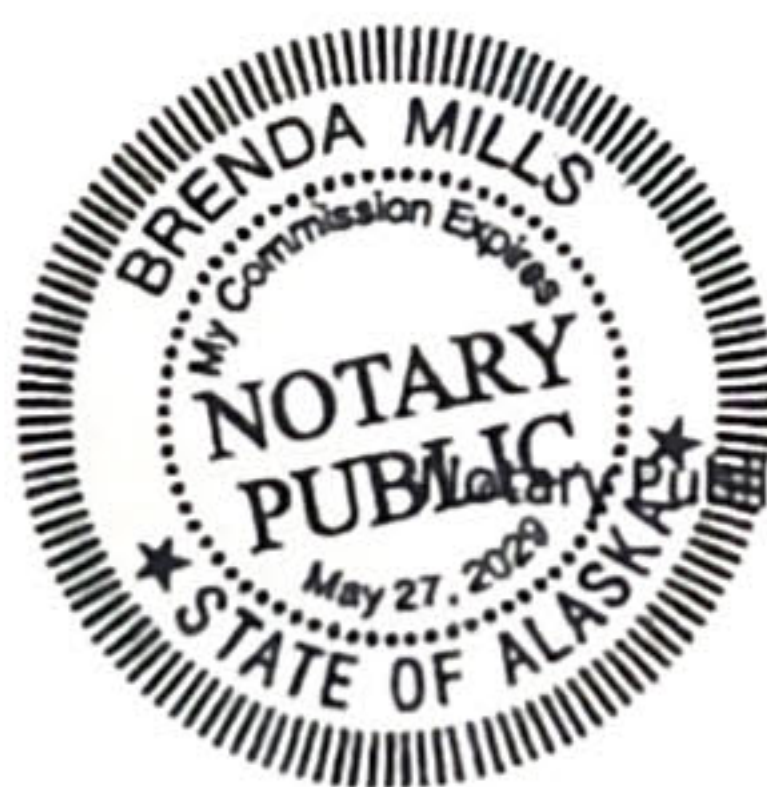

LANDLORD CONSENT, LEASE ASSUMPTION, AND CONDITIONAL REASSIGNMENT AGREEMENT

This **Landlord Consent, Lease Assumption, and Conditional Reassignment Agreement** ("Agreement") is entered into as of March 25, 2026, by and among:

Darlin Enterprises, LLC, as Landlord ("Landlord");

NOMO Gold, LLC, an Alaska limited liability company ("Seller"); and

Rik in Alaska, LLC, an Alaska limited liability company ("Buyer").

RECITALS

A. Seller is the tenant under that certain Lease Agreement dated March 25, 2026 (the "Lease"), covering the real property commonly known as Mile Post 248.1, Unit 4, Parks Highway, Healy, Alaska, 99743 and recently assigned the address of 155 Equinox Loop, Suite 4A, Healy, Alaska 99743 (the "Premises").

B. Seller and Buyer have entered into that certain Asset Purchase and Sale Agreement dated 7/26/, 2026 (the "Purchase Agreement"), pursuant to which Buyer is purchasing Seller's cannabis retail business operated at the Premises.

C. As part of the Purchase Agreement, Buyer will assume the Lease, subject to Landlord's consent.

D. Seller is financing a portion of the purchase price and has retained a security interest in certain assets of the Business, including Buyer's leasehold interest, to the extent permitted by law.

E. The parties desire to establish their respective rights regarding the Lease.

NOW, THEREFORE, in consideration of the mutual covenants contained herein, the parties agree as follows:

1. Landlord Consent

Landlord hereby consents to the assignment and assumption of the Lease from Seller to Buyer effective as of the Closing Date under the Purchase Agreement.

2. Assumption of Lease

Buyer accepts the assignment of the Lease and assumes all obligations, duties, and liabilities of Tenant arising under the Lease from and after the Closing Date.

Buyer agrees to perform every covenant contained in the Lease.

3. Seller Obligations

Except for obligations arising prior to Closing, Seller shall have no further obligations under the Lease from and after the Closing Date to the extent Landlord agrees such obligations are assumed by Buyer.

Nothing herein releases Seller from obligations that cannot legally be released without Landlord's separate written agreement.

4. Recognition of Seller's Security Interest

Landlord acknowledges that Seller has retained a security interest in certain assets of the Business pursuant to the Purchase Agreement, Promissory Note, Security Agreement, and related Loan Documents.

5. Notice of Lease Default

Before exercising any right to terminate the Lease for default occurring after Closing, Landlord shall provide written notice of such default to both Buyer and Seller.

Notice to Seller shall be provided at the address specified below or such other address as Seller may designate in writing.

6. Seller's Right to Cure

Seller shall have the right, but not the obligation, to cure any monetary default under the Lease within thirty (30) days after receipt of Landlord's notice.

If the default is non-monetary and cannot reasonably be cured within thirty (30) days, Seller shall have such additional time as is reasonably necessary, provided Seller commences cure within the initial thirty (30) day period and diligently pursues completion.

During any applicable cure period, Landlord shall not terminate the Lease.

7. Buyer Default Under Loan Documents

If Buyer defaults under the Purchase Agreement, Promissory Note, Security Agreement, Personal Guaranty, or any related Loan Document beyond any applicable notice and cure period, Seller may elect to enforce its rights in the collateral.

If Buyer fails to execute such documents, this Agreement shall constitute Buyer's irrevocable authorization for Seller to seek specific performance and all other remedies available at law or in equity.

9. Landlord Recognition

Provided Seller has cured all existing Lease defaults and satisfies Landlord's reasonable qualification requirements under the Lease, Landlord agrees not to unreasonably withhold, condition, or delay its consent to Seller's reassumption of the Lease following Buyer's default.

10. Security Deposit

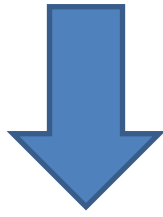
