**APPLICATION FOR CERTIFICATE OF AUTHORITY  
FOR A JOINT TITLE PLANT**

Under AS 21.66.210, two or more title insurance companies or two or more title insurance limited producers, or a combination of title insurance companies and title insurance limited producers, may apply to the director to form an association, corporation or other legal entity, for the purpose of engaging in the business of preparing abstracts of title searches from public records or from records to be owned by the entity, upon the basis of which a title insurance limited producer or a title insurance company will issue title policies.

Application is hereby made to the Director of Insurance for a certificate of authority to transact business as a joint title plant company under AS 21.66.210 in the state of Alaska during the license year beginning July 1, 20\_\_\_\_.

(AS 21.06.250 & 3 AAC 31.060)	

**A certificate of authority issued under this section remains in effect until suspended or revoked by the director. The certificate is subject to annual continuation for a fee of \$600. (AS 21.06.250 & 3 AAC 31.060) Every plant issued a certificate of authority shall notify the director promptly of every change occurring under this section.**

**Amendment Fees:**

\$100 Basic amendment of certificate of authority (name change).

\$100 Filing fee for either amended bylaws or amended articles of incorporation or organization.
