### STIPULATED AGREEMENT AND ORDER

The Division of Insurance, Department of Commerce and Economic Development ("the division") and S & II Inc. d/b/a Associated Insurance Services ("S & H Inc."), the licensee in this case, stipulate and agree that the failure to timely renew its license and the unlicensed activity that occurred during the time license #9286 was in lapse status are resolved as follows:

- 1. S & H Inc. admits that while its firm insurance license was in lapse status, from February 20, 1996 through February 23, 1996, S & H Inc. transacted the business of insurance, in violation of AS 21.27.380(b).
- 2. Under AS 21.27.420(c), the division agrees to reinstate S & H Inc.'s insurance firm license subject to the condition that S & H Inc. pay a civil penalty of \$500, with \$250 suspended. The unsuspended portion of the penalty is payable no later than twelve months from the date this agreement and order is signed by the director.
