STIPULATED AGREEMENT AND ORDER

The Division of Insurance, Department of Commerce and Economic Development (division) and Sharon Jackson (Jackson), the licensee in this case, stipulate and agree that the failure to timely reinstate license #4535, and the unlicensed activity that occurred during the time the license was canceled are resolved as follows:


1. Jackson admits that during the time the individual license was canceled, from February 23, 1997 through April 28, 1997, she transacted the business of insurance, in violation of AS 21.27.380(b).
2. Under AS 21.27.420(c), the division agrees to reinstate Jackson's insurance license subject to the condition that she pay a civil penalty of \$842.84, which is payable no later than twelve months from the date this agreement and order is signed by the director.
