STIPULATED AGREEMENT AND ORDER

The Division of Insurance, Department of Community and Economic Development (division) and David B. Alutius (Mr. Alutius), the licensee in this case, stipulate and agree that the failure to timely renew license #13690 and the unlicensed activity that occurred during the time the license was in lapse status are resolved as follows:

1. Mr. Alutius admits that while his individual in a firm adjuster insurance license was in lapse status, from September 3, 1999 through September 9, 1999, he transacted the business of insurance, in violation of AS 21.27.380(b).
2. Prior to this instance, Mr. Alutius has never allowed his Alaska insurance license to lapse and, to the division's knowledge, he has not engaged in unlicensed activity.
3. Under AS 21.27.420(c), the division agrees to reinstate Mr. Alutius' insurance license subject to the condition that he pay a civil penalty of \$100, as allowed under AS 21.27.440, which is due no later than twelve months from the date this agreement and order is signed by the director.




