STIPULATED AGREEMENT AND ORDER

The Division of Insurance (division) and Andrea J. Johnson (Ms. Johnson), the licensee in this case, stipulate and agree that the unlicensed activity that occurred before license #23956 was issued and in effect is resolved as follows:

1. Ms. Johnson admits that from the time she first became employed by Crawford & Company in September 2000 and before she applied for her insurance adjuster license in February 2001 to the time when the division issued her license, from September 18, 2000 to April 9, 2001, she transacted the business of insurance, in violation of AS 21.27.010(a).
2. Prior to this instance and to the division's knowledge, Ms. Johnson has not engaged in unlicensed activity.
3. Ms. Johnson agrees to pay a civil penalty under AS 21.27.440(a) of \$1,000 with \$250 suspended. The unsuspended portion of the penalty is due no later than six months from the date this agreement and order is signed by the director.

4. In the event Ms. Johnson violates the insurance code or applicable regulations during the next two years, the suspended portion of the fine referenced in paragraph 3 will be reinstated. Ms. Johnson also will be subject to any and all sanctions authorized by the insurance code including imposition of additional fines or penalties.

5. By signing this agreement, Ms. Johnson understands and agrees that any failure to comply with the conditions of this agreement will be grounds to revoke, suspend, or not renew Alaska insurance license #23956.

6. Ms. Johnson understands that this agreement is not binding on the parties unless and until the director signs the order approving the agreement.




