## STIPULATED AGREEMENT AND ORDER

The Division of Insurance (division) and Edward L. Roberts (Mr. Roberts), the licensee in this case, stipulate and agree that the unlicensed activity that occurred before license #25021 was issued and in effect is resolved as follows:

- 1. Mr. Roberts admits that from the time he first became employed by Crawford & Company in October 2000 and before he applied for his insurance adjuster license in May 2001 to the time when the division issued his license, from October 2000 to July 20, 2001, he transacted the business of insurance, in violation of AS 21.27.010(a).
- 2. Prior to this instance and to the division's knowledge, Mr. Roberts has not engaged in unlicensed activity.
- 3. Mr. Roberts agrees to pay a civil penalty under AS 21.27.440(a) of \$1,000 with \$250 suspended. The unsuspended portion of the penalty is due no later than six months from the date this agreement and order is signed by the director.

- 4. In the event Mr. Roberts violates the insurance code or applicable regulations during the next two years, the suspended portion of the fine referenced in paragraph 3 will be reinstated. Mr. Roberts also will be subject to any and all sanctions authorized by the insurance code including imposition of additional fines or penalties.
- 5. By signing this agreement, Mr. Roberts understands and agrees that any failure to comply with the conditions of this agreement will be grounds to revoke, suspend, or not renew Alaska insurance license #25021.
- 6. Mr. Roberts understands that this agreement is not binding on the parties unless and until the director signs the order approving the agreement.
