STIPULATED AGREEMENT AND ORDER

The Division of Insurance (division) and David S. Yeskin (Mr. Yeskin), the licensee in this case, stipulate and agree that the unlicensed activity that occurred during the time license #27527 was in lapse status is resolved as follows:

1. On March 6, 2007, the division sent Mr. Yeskin a license renewal application. On May 17, 2007, the division notified Mr. Yeskin that his insurance producer license had lapsed for failure to renew.
2. On July 10, 2007, the division received application requirements necessary to reinstate Mr. Yeskin's license, and the division reinstated his license effective July 19, 2007. As required by the division, a notarized statement was submitted listing whether business had been transacted while the license was in lapse status. The statement indicated that three insurance transactions occurred between May 17, 2007 and July 3, 2007 while he was not appropriately licensed.
3. Prior to this instance, to the division's knowledge, Mr. Yeskin has not engaged in unlicensed activity or otherwise violated the insurance code.

1 4. Mr. Yeskin agrees to pay a civil penalty under AS 21.27.440(a) of
2 \$489.20, which equals the amount of commission earned for the unlicensed activity that
3 occurred between May 17, 2007 and July 3, 2007, with \$239.20 suspended. The unsuspended
4 portion of the penalty is payable at the time Mr. Yeskin is notified that the director has signed
5 the order approving this agreement.


7 5. In the event Mr. Yeskin violates the insurance code or applicable
8 regulations during the next two years, the suspended portion of the penalty referenced in
9 paragraph 4 will be reinstated. Mr. Yeskin also will be subject to any and all sanctions
10 authorized by the insurance code including imposition of additional fines or penalties.

11 6. By signing this agreement, Mr. Yeskin understands and agrees that any
12 failure to comply with the conditions of this agreement will be grounds to revoke, suspend, or
13 not renew Alaska insurance license #27527.


14 7. Mr. Yeskin understands that this agreement is not binding on the parties


