STIPULATED AGREEMENT AND ORDER

The Division of Insurance (division) and David P. Rupp (Mr. Rupp), the licensee in this matter, stipulate and agree that the unlicensed activity that occurred during the time Mr. Rupp did not hold an active Alaska producer license is resolved as follows:

- On or about October 29, 2009, the division sent Mr. Rupp a renewal application for insurance producer license #40359. On January 8, 2010, the division notified Mr. Rupp that his license had lapsed for failure to renew
- 2. After receiving the application requirements necessary to reinstate Mr. Rupp's license, the division reinstated his license effective March 17, 2010.
- 3. As required by the division, Mr. Rupp submitted a notarized statement listing whether business had been transacted when he was not appropriately licensed. The statement indicated that six insurance transactions occurred between January 8, 2010 and March 4, 2010.
- 4. Mr. Rupp agrees to pay a civil penalty under AS 21.27.440(a) in the amount of \$1,402, for the unlicensed activity that occurred between January 8, 2010 and

March 4, 2010, with \$700 suspended. The civil penalty is payable at the time Mr. Rupp is notified that the director has signed the order approving this agreement.

- 5. In the event Mr. Rupp violates the insurance code or applicable regulations during the next two years, the suspended portion of the fine referenced in paragraph 4 will be reinstated. Mr. Rupp also will be subject to any and all sanctions authorized by the insurance code including imposition of additional fines or penalties.
- 6. By signing this agreement, Mr. Rupp understands and agrees that any failure to comply with the terms of this agreement may be grounds to revoke, further suspend, or non-renew Alaska insurance license number 40359.
- 7. Mr. Rupp understands that this agreement is not binding on the parties unless and until the director signs the order approving the agreement.
