STIPULATED AGREEMENT AND ORDER

The Division of Insurance (division) and Barbara E. McClellan (Ms. McClellan), the licensee in this case, stipulate and agree that the unlicensed activity that occurred during the time license #86406 was in lapse status is resolved as follows:

1. On June 25, 2010, the division sent Ms. McClellan a license renewal application. On October 1, 2010, the division notified Ms. McClellan that her insurance producer license had lapsed for failure to renew.
2. On October 27, 2010, the division received application requirements necessary to reinstate Ms. McClellan's license, and the division reinstated her license effective December 24, 2010. As required by the division, a notarized statement was submitted listing whether business had been transacted while the license was in lapse status. The statement indicated that one insurance transaction occurred on October 27, 2010 while she was not appropriately licensed.
3. Prior to this instance, to the division's knowledge, Ms. McClellan has not engaged in unlicensed activity or otherwise violated the insurance code.

1 4. Ms. McClellan agrees to pay a civil penalty under AS 21.27.440(a) of
2 \$1,130.25, for the unlicensed activity that occurred on October 27, 2010, with \$730.25
3 suspended. The unsuspended portion of the penalty is payable at the time Ms. McClellan is
4 notified that the director has signed the order approving this agreement.

5
6 5. In the event Ms. McClellan violates the insurance code or applicable
7 regulations during the next two years, the suspended portion of the penalty referenced in
8 paragraph 4 will be reinstated. Ms. McClellan also will be subject to any and all sanctions
9 authorized by the insurance code including imposition of additional fines or penalties.

10 6. By signing this agreement, Ms. McClellan understands and agrees that
11 any failure to comply with the conditions of this agreement will be grounds to revoke, suspend,
12 or not renew Alaska insurance license #86406.

13 7. Ms. McClellan understands that this agreement is not binding on the
14 parties unless and until the director signs the order approving the agreement.


