## STIPULATED AGREEMENT AND ORDER

The Division of Insurance (division) and Michael A. Mathews (Mr. Mathews), the licensee in this case, stipulate and agree that the unlicensed activity that occurred during the time license #70406 was in lapse status is resolved as follows:

- 1. On July 1, 2009, the division sent Mr. Mathews a license renewal application. On October 9, 2009, the division notified Mr. Mathews that his insurance producer license had lapsed for failure to renew.
- 2. On July 27, 2010, the division received electronic application requirements necessary to reinstate Mr. Mathews' license. The application indicated that Mr. Mathews had left the employ of Arrowhead Insurance in March 2009 and became employed by Atlas General Insurance Services, LLC in March 2009. The division reinstated his license effective July 28, 2010. As required by the division, Mr. Mathews submitted a notarized statement indicating whether business had been transacted while his license was in lapse status. The statement indicated that one insurance transaction occurred on November 9, 2009 while he was not appropriately licensed.

I	3. Prior to this instance, to the division's knowledge, Mr. Mathews has not
2	engaged in unlicensed activity or otherwise violated the insurance code.
3	4. Mr. Mathews agrees to pay a civil penalty under AS 21.27.440(a) of
4	\$1,425.26, for the unlicensed activity that occurred on November 9, 2009, with \$700
5	suspended. The unsuspended portion of the penalty is payable at the time Mr. Mathews is
6 7	notified that the director has signed the order approving this agreement.
8	5. In the event Mr. Mathews violates Alaska's insurance laws during the
9	next two years, the suspended portion of the penalty referenced in paragraph 4 will be
10	reinstated. Mr. Mathews also will be subject to any and all sanctions authorized by the
11	insurance code including imposition of additional fines or penalties.
12	6. By signing this agreement, Mr. Mathews understands and agrees that any
13	failure to comply with the conditions of this agreement will be grounds to revoke, suspend, or
14	not renew Alaska insurance license #70406.
15	7. Mr. Mathews understands that this agreement is not binding on the
16   17	parties unless and until the director signs the order approving the agreement.
