STIPULATED AGREEMENT AND ORDER

The Division of Insurance (division) and John F. Ranhofer (Mr. Ranhofer), the licensee in this matter, stipulate and agree to the following:

I. BACKGROUND

- A. On or about August 26, 2011, Mr. Ranhofer applied for a nonresident individual insurance producer license to sell health insurance products.
- B. Mr. Ranhofer disclosed an administrative action taken by the National Association of Securities Dealers in 2005, but he failed to disclose that his home state of California took administrative action and issued a restricted license in an Order of Summary Revocation and for Issuance of a Restricted License based on the FINRA action. This order became effective August 30, 2005 and is still in effect.
 - C. The director has fully reviewed Mr. Ranhofer's file.

II. TERMS OF AGREEMENT

1. The division will issue Mr. Ranhofer a nonresident individual insurance producer license subject to the following conditions.

If his license in California is still apleting the renewal requirements, his Alaska license will continue to be time his California license is unrestricted. If Mr. Ranhofer's license in ricted, his Alaska license will be renewed with no restrictions.
- By signing this agreement, Mr. Ranhofer understands and agrees that any rith the terms of this agreement may be grounds to revoke, suspend, or nonsurance license.
