STIPULATED AGREEMENT AND ORDER

The Division of Insurance (division) and Mary E. Glines (Ms. Glines), the licensee in this case, stipulate and agree that the unlicensed activity that occurred during the time she was not appropriately licensed is resolved as follows:

1. On February 9, 2009, the division notified Ms. Glines that, since it had received notification from the National Association of Insurance Commissioners through its producer licensing database that she was no longer actively licensed in her home state of Washington, her Alaska license would be cancelled unless she provided information that allowed her to continue to be licensed in Alaska. This was done because under AS 21.27.270(b)(1) her Alaska license was issued contingent upon her continually being licensed in her resident state. She was given 30 days to respond. Since she did not reply, the division cancelled her license on March 19, 2009.

2. Although inquiries were made by S&C personnel on how to reinstate her license, it was not until November 10, 2011 that the division received an application to reinstate Ms. Glines' license. All the requirements necessary to reinstate the license were not received

1 until April 19, 2012, and the division reinstated her license effective that day. As required by
2 the division, Ms. Glines submitted a notarized statement indicating whether business had been
3 transacted while she was not appropriately licensed. The statement indicated that several
4 insurance transactions occurred between March 19, 2009 and April 4, 2012, with \$17,550
5 earned in commissions.

7 3. Ms. Glines agrees to pay a civil penalty under AS 21.27.440 in the
8 amount of \$17,550 for the unlicensed activity that occurred between March 19, 2009 and April
9 4, 2012, with \$9,000 suspended. The unsuspended portion of the penalty is payable at the time
10 Ms. Glines is notified that the director has signed the order approving this agreement.

11 4. In the event Ms. Glines violates Alaska's insurance laws during the next
12 two years, the suspended portion of the penalty referenced in paragraph 3 will be reinstated.
13 Ms. Glines also will be subject to any and all sanctions authorized by the insurance code
14 including imposition of additional penalties.

15 5. By signing this agreement, Ms. Glines understands and agrees that any
16 failure to comply with the conditions of this agreement will be grounds to revoke, suspend, or
17 not renew Alaska insurance license #5713.

18 7. Ms. Glines understands that this agreement is not binding on the parties
19 unless and until the director signs the order approving the agreement.
