



1                   4.       Mr. Tobeck agrees to pay a civil penalty under AS 21.27.440(a) of  
2 \$25,000 for the unlicensed activity that occurred between March 9, 2012 and October 3, 2012,  
3 with \$15,000 suspended. The unsuspended portion of the penalty is payable within three  
4 months from the time Mr. Tobeck is notified that the director has signed the order approving  
5 this agreement.


6                   5.       In the event Mr. Tobeck violates Alaska's insurance laws during the next  
7 two years, the suspended portion of the penalty referenced in paragraph 4 will be reinstated.  
8 Mr. Tobeck also will be subject to any and all sanctions authorized by the insurance code  
9 including imposition of additional penalties.

10                  6.       By signing this agreement, Mr. Tobeck understands and agrees that any  
11 failure to comply with the conditions of this agreement will be grounds to revoke, suspend, or  
12 not renew Alaska insurance license #60736.


13                  7.       Mr. Tobeck understands that this agreement is not binding on the parties  
14 unless and until the director signs the order approving the agreement.




