STIPULATED AGREEMENT AND ORDER

The Division of Insurance, Department of Commerce, Community, and Economic Development, State of Alaska (division) and Adrian Russell Robison, a.k.a. A. Russell Robison (Mr. Robison), the licensee in this matter, stipulate and agree to the following:

I. BACKGROUND

- 1. On or about February 3, 2010, the division issued a nonresident Life and Health producer license having license number 84280 to Mr. Robison.
- 2. On or about December 9, 2013, Mr. Robison entered into a Stipulation with the State of Idaho Department of Insurance in which Mr. Robison stipulated and agreed that he plead guilty in the United States District Court for the District of Idaho to the felony crime of Making and Subscribing a False Tax Return, in violation of 26 U.S.C. § 7206(1).
- 3. Mr. Robison, in the above-referenced Stipulation, also stipulated and agreed that it was appropriate for the Director of the State of Idaho Department of Insurance to revoke Mr. Robison's Idaho resident insurance producer license having license number 70676 which said director did by order on or about December 9, 2013.

- 4. Mr. Robison's conviction of a felony constitutes grounds for revoking Mr. Robison's Alaska nonresident producer license under AS 21.27.410(a)(7).
- 5. The revocation of Mr. Robison's resident producer license in Idaho by the Idaho Director of Insurance constitutes grounds for revoking Mr. Robison's Alaska nonresident producer license under AS 21.27.410(a)(11).
- 6. On or about December 24, 2013, the Alaska Division of Insurance notified Mr. Robison that under AS 21.27.410(a)(7) and (11) the director may take action against Mr. Robison's Alaska insurance license.
 - 7. The director has fully reviewed Mr. Robison's file.

II. TERMS OF AGREEMENT

- 1. Mr. Robison stipulates and agrees that, under the circumstances set forth in paragraphs two, three, four, and five above, it is appropriate that the director revoke Alaska nonresident license number 84280, currently maintained by him, effective as of the date of this order.
- 2. Mr. Robison stipulates and agrees not to seek to be licensed in this state by the division for a period of 20 years from the effective date of this order.
- 3. Mr. Robison stipulates and agrees that he enters into this agreement voluntarily with full knowledge of all rights he may have in this matter.
