## STATEMENT OF ISSUES

Marianne K. Burke, Director, Division of Insurance, Department of Commerce and Economic Development, State of Alaska, states as follows:

- On or about January 23, 1995, a third-party administrator registration application was received by the Division of Insurance (Division) from Bertholon-Rowland Corp., d/b/a Bertholon-Rowland Insurance Brokers (Bertholon-Rowland).
- 2. AS 21.27.640(b)(5)(D) requires that an applicant for registration as a third-party administrator provide:

certified financial statements for the prior two years prepared by an independent certified public accountant that establish that <u>the applicant is solvent</u>, that the applicant's system of accounting, internal control, and procedure is operating effectively to provide reasonable assurance that money is promptly accounted for and paid to the person entitled to the money, and any other

- 3. Included with the application were the certified financial statements required under AS 21.27.640(b)(5)(D). A review of these statements by Dean George, one of the Division's financial examiners, reveals that Bertholon-Rowland is not solvent. The financial statements show a stock holder's deficit of \$2,369,483 as of June 30, 1994 and \$3,363,660 as of June 30, 1993.
- 4. Pursuant to AS 21.27.640(a), the application of Bertholon-Rowland Corp., d/b/a Bertholon-Rowland Insurance Brokers, for registration as a third-party administrator is hereby denied unless and until the requirements under AS 21.27.640(b)(5)(D) are met.
