The statements are due on the 10th day of the first month of each quarter. This condition will remain in effect for two years from the date the director signs this agreement and order.

b. Elander will pay a civil fine of \$500 with \$250 suspended. The unsuspended portion of the penalty is payable prior to licensing unless other payment arrangements are made.

- 3. In the event Elander violates the insurance code or applicable regulations during the next two years, the suspended portion of the fine referenced in paragraph 2b will be reinstated. Elander also will be subject to any and all sanctions authorized by statute including imposition of additional fines or penalties.
- 4. By signing this agreement, Elander understands and agrees that any failure to comply with the conditions of this agreement will be grounds to revoke, suspend, or non-renew his Alaska insurance license.
