ORDER RELEASING DEPOSITED ASSETS OF AMERICAN INTERNATIONAL SPECIALTY LINES INSURANCE COMPANY HELD UNDER AS 21.09.090 AND AS 21.24.130

BACKGROUND:

- 1. As required by AS 21.09.090, on or about April 3, 1973, Alaska Insurance Company, domiciled in Alaska, deposited the necessary funds with the State of Alaska as a condition of becoming authorized to transact the business of insurance in Alaska under certificate of authority number 1023.
- 2. The company name was most recently changed on September 25, 1992 to American International Specialty Lines Insurance Company (AISLIC).
 - 3. On December 28, 2007, AISLIC redomesticated to Illinois.
 - 4. On March 27, 2008, AISLIC requested release of the above-referenced deposit.

FINDINGS:

The director finds that:

- A. Because of its redomestication in Illinois, the requirement of a deposit in the State of Alaska under AS 21.09.090 no longer applies to AISLIC.
- B. AISLIC has complied with the requirements of AS 21.24.130(c) and (e) and there is no longer a need for AISLIC's deposit to be held in Alaska.

IT IS HEREBY ORDERED:

Under the authority of AS 21.24.130(e), the director authorizes the release of the First National Bank Alaska security in the amount of \$3,390,000 that is being held in the State of Alaska as a deposit for American International Specialty Lines Insurance Company. The depository account number 57-7514-00 may be closed releasing all parties from the Deposit Agreement signed in 1973.

This order takes effect May 8, 2008.
