WHEREAS, the Certificate of Authority for INTER-AMERICAN

LIFE INSURANCE COMPANY to transact the business of insurance in

the state of Alaska was suspended effective June 30, 1992, and

that suspension has continued to the present.

It is hereby ordered, pursuant to the provision of AS 21.09.140(a) that Certificate of Authority No F-0743 issued to INTER-AMERICAN LIFE INSURANCE COMPANY to transact the business of insurance in the state of Alaska shall be suspended for a period of one year unless terminated sooner as permitted by statute.
