27 WHEREAS, a Certificate of Authority to transact the  
28 business of insurance in the State of Alaska has been issued to  
29 **MONARCH LIFE INSURANCE COMPANY**, domiciled in Massachusetts.

30 WHEREAS, the Supreme Judicial Court for Suffolk  
31 county, Commonwealth of Massachusetts, placed the **MONARCH LIFE**  
32 **INSURANCE COMPANY** under permanent injunction in an order  
33 Appointing Permanent Receiver, dated July 27, 1994. The order  
34 appointed the Commissioner of Insurance of the Commonwealth of  
35 Massachusetts as Permanent Receiver to rehabilitate the company  
36 and conserve its assets. The company remains in rehabilitation  
37 at the present time.

38 WHEREAS, the Certificate of Authority for **MONARCH LIFE**  
39 **INSURANCE COMPANY**, to transact the business of insurance in the  
40 State of Alaska was suspended effective July 28, 1994, and that  
41 suspension has been continued to the present.


1 It is hereby ordered pursuant to the provision of AS  
2 21.09.150(c) that Certificate of Authority No F-1311 issued to  
3 **MONARCH LIFE INSURANCE COMPANY** to transact the business of  
4 insurance in the State of Alaska shall continue to be suspended  
5 for a period of one year unless terminated sooner as permitted  
6 by statute. Pursuant to AS 21.09.160(b), this suspension shall  
7 automatically suspend the authority of all its agents to act as  
8 agents of **MONARCH LIFE INSURANCE COMPANY** in this state.

9 During the period of suspension, **MONARCH LIFE INSURANCE**  
10 **COMPANY** shall not solicit or write any new or renewal business  
11 in Alaska, but shall file the Annual Statement, pay fees and  
12 any taxes due as provided by AS 21.09.170(b).

13 It is further ordered that Certificate of Authority No.  
14 F-1311 will continue to be held in safekeeping by **MONARCH LIFE**  
15 **INSURANCE COMPANY** until such time as this Order of Suspension  
16 is lifted or is replaced by an Order of Revocation.
