21 WHEREAS, a Certificate of Authority to transact the  
22 business of insurance in the State of Alaska has been issued to  
23 US INTERNATIONAL REINSURANCE COMPANY, domiciled in New  
24 Hampshire.

25 WHEREAS, US INTERNATIONAL REINSURANCE COMPANY has  
26 ceased writing any new or renewal business since 1992 and is in  
27 voluntary runoff.

28 WHEREAS, US INTERNATIONAL REINSURANCE COMPANY has ceded  
29 100% of its assets and liabilities, in excess of the minimum  
30 capital and surplus, to its parent, the HOME INSURANCE COMPANY  
31 who is under an Order of Supervision by the New Hampshire  
32 Department of Insurance.

33 It is hereby ordered pursuant to the provision of AS  
34 21.09.150(c) that Certificate of Authority No F-1676 issued to  
35 US INTERNATIONAL REINSURANCE COMPANY to transact the business


1 of insurance in the State of Alaska shall continue to be  
2 suspended for a period of one year unless terminated sooner as  
3 permitted by statute. Pursuant to AS 21.09.160(b), this  
4 suspension shall automatically suspend the authority of all its  
5 agents to act as agents of **US INTERNATIONAL REINSURANCE COMPANY**  
6 in this state.

7 During the period of suspension, **US INTERNATIONAL**  
8 **REINSURANCE COMPANY** shall not solicit or write any new or  
9 renewal business in Alaska, but shall file the Annual  
10 Statement, pay fees and any taxes due as provided by AS  
11 21.09.170(b).

12 It is further ordered that Certificate of Authority No.  
13 F-1676 will continue to be held in safekeeping by **US**  
14 **INTERNATIONAL REINSURANCE COMPANY** until such time as this Order  
15 of Suspension is lifted or is replaced by an Order of  
16 Revocation.
