WHEREAS, a Certificate of Authority to transact the business of insurance in the State of Alaska has been issued to PINNACLE INSURANCE COMPANY, domiciled in Georgia.

WHEREAS, the State of Georgia has placed PINNACLE INSURANCE COMPANY in rehabilitation under a Consent Order, dated July 16, 1997. The company remains in rehabilitation at the present time.

WHEREAS, the Certificate of Authority for PINNACLE INSURANCE COMPANY OF OMAHA, to transact the business of insurance in the State of Alaska was suspended effective September 6, 1997, and that suspension has been continued to the present.

WHEREAS, the 1st quarter 1999 Annual Statement of PINNACLE INSURANCE COMPANY showed a capital and surplus as regards to Policyholders in the amount of \$1,396,313. The Alaska required minimum capital and surplus per AS 21.09.070(b) for the kinds of insurance authorized by the state of domicile for this insurer is \$5,250,000. This results in an impairment of \$3,573,085.

It is hereby ordered pursuant to the provision of AS

21.09.140(a) that Certificate of Authority No F-1655 issued to

PINNACLE INSURANCE COMPANY to transact the business of

insurance in the State of Alaska shall continue to be suspended

for a period of one year unless terminated sooner as permitted

by statute.

During the period of suspension, PINNACLE INSURANCE

COMPANY shall not solicit or write any new or renewal business
in Alaska, but shall file the Annual Statement, pay fees and
any taxes due as provided by AS 21.09.170(b).

It is further ordered that Certificate of Authority No.

F-1655 will continue to be held in safekeeping by PINNACLE

INSURANCE COMPANY until such time as this Order of Suspension
is lifted or is replaced by an Order of Revocation.
