19 WHEREAS, a Certificate of Authority to transact the  
20 business of insurance in the State of Alaska has been issued to

23 INTERNATIONAL INSURANCE COMPANY, to transact the business of  
24 insurance in the State of Alaska was suspended effective  
25 December 14, 1995, and that suspension has been continued to  
26 the present.

WHEREAS, The 1999 Annual Statement of ATLANTA  
INTERNATIONAL INSURANCE COMPANY showed during 1999 they  
continued in runoff status and are not writing any new  
business.



1 business of insurance in the state of Alaska shall be suspended  
2 for a period of one year unless terminated sooner as permitted  
3 by statute. Pursuant to AS 21.09.160(b), this suspension shall  
4 automatically suspend the authority of all its agents to act as  
5 agents of **ATLANTA INTERNATIONAL INSURANCE COMPANY** in this  
6 state.

7 During the period of suspension, **ATLANTA INTERNATIONAL**  
8 **INSURANCE COMPANY** shall not solicit or write any new business  
9 in Alaska, but shall file the Annual Statement, pay fees and  
10 any taxes due as provided by AS 21.09.170(b).

11 It is further ordered that Certificate of Authority No. F-  
12 0551 will continue to be held in safekeeping by **ATLANTA**  
13 **INTERNATIONAL INSURANCE COMPANY** until such time as this Order  
14 of Suspension is lifted or is replaced by an Order of  
15 Revocation.
