**WHEREAS**, a Certificate of Authority to transact the business of insurance

**WHEREAS**, the Circuit Court of Cole County, Missouri entered an Order  
of Rehabilitation dated March 30, 1993, appointing the director of the Department

1           **FINANCIAL SECURITY LIFE INSURANCE COMPANY.** The company  
2 continues under the Order of Supervision to the present time.

3           **WHEREAS,** the Certificate of Authority of **AMERICAN FINANCIAL**  
4 **SECURITY LIFE INSURANCE COMPANY** to transact the business of  
5 insurance in the State of Alaska was suspended effective September 2, 1992, for  
6 a period of one year and that suspension has continued to the present.

7           **WHEREAS,** the 2000 Annual Statement of **AMERICAN FINANCIAL**  
8 **SECURITY LIFE INSURANCE COMPANY** showed that the capital and  
9 surplus fails to meet the requirement of AS 21.09.070.

10           **IT IS HEREBY ORDERED,** pursuant to the provision of AS 21.09.150 (c)  
11 that Certificate of Authority No F- 0693 issued to **AMERICAN FINANCIAL**  
12 **SECURITY LIFE INSURANCE COMPANY** to transact the business of  
13 insurance in the State of Alaska shall be suspended for a period of one year unless  
14 terminated sooner as permitted by statute. Pursuant to AS 21.09.160 (b), this  
15 suspension shall automatically suspend the authority of all its agents to act as  
16 agents of **AMERICAN FINANCIAL SECURITY LIFE INSURANCE**  
17 **COMPANY** in this state.

18           **IT IS FURTHER ORDERED,** that during the period of suspension,  
19 **AMERICAN FINANCIAL SECURITY LIFE INSURANCE COMPANY**  
20 shall not solicit or write any new business in the State of Alaska, but shall file the  
21 Annual Statement, pay fees and any taxes due as provided by AS 21.09.170(b).


22           **IT IS FURTHER ORDERED** that Certificate of Authority No. F-0693
