WHEREAS, the Certificate of Authority issued to NORTHWESTERN NATIONAL INSURANCE COMPANY OF MILWAUKEE, WISCONSIN ("Northwestern National") to transact the business of insurance in the State of Alaska was suspended on December 28, 1992 and that suspension has been continued to the present.
