4 **WHEREAS**, the Certificate of Authority for **MONARCH LIFE**  
5 **INSURANCE COMPANY**, to transact the business of insurance in the State of  
6 Alaska was suspended effective July 28, 1994, and that suspension has been  
7 continued to the present.



9 **IT IS HEREBY ORDERED**, pursuant to the provision of AS 21.09.150(c)  
10 that Certificate of Authority No F- 1311 issued to **MONARCH LIFE**  
11 **INSURANCE COMPANY** to transact the business of insurance in the State of  
12 Alaska shall continue to be suspended for a period of one year unless terminated  
13 sooner as permitted by statute. Pursuant to AS 21.09.160(b), this suspension shall  
14 automatically suspend the authority of all its agents to act as agents of  
15 **MONARCH LIFE INSURANCE COMPANY** in this state.

16  
17 During the period of suspension, **MONARCH LIFE INSURANCE**  
18 **COMPANY** shall not solicit or write any new or renewal business in Alaska, but  
19 shall file the Annual Statement, pay fees and any taxes due as provided by AS  
20 21.09.170(b).

21  
22 **IT IS FURTHER ORDERED**, Certificate of Authority No. F-1311 will  
23 continue to be held in safekeeping by **MONARCH LIFE INSURANCE**  
24 **COMPANY** until such time as this Order of Suspension is replaced by an order  
25 of Revocation or the Certificate of Authority is surrendered.
