WHEREAS, a Certificate of Authority to transact the business of insurance

11 (2) that Certificate of Authority No. F-0551 issued to **ATLANTA**
12 **INTERNATIONAL INSURANCE COMPANY** to transact the business of
13 insurance in the State of Alaska shall be suspended for a period of one year unless
14 terminated sooner as permitted by statute. Pursuant to AS 21.09.160 (b), this
15 suspension shall automatically suspend the authority of all its agents to act as
16 agents of **ATLANTA INTERNATIONAL INSURANCE COMPANY** in this
17 state.

21 **IT IS FURTHER ORDERED**, that during the period of suspension
22 **ATLANTA INTERNATIONAL INSURANCE COMPANY** shall not solicit or
23 write any new business in Alaska, but shall file the Annual Statement, pay fees
24 and any taxes due as provided by AS 21.09.170 (b).

29 will continue to be held in safekeeping by **ATLANTA INTERNATIONAL**


