WHEREAS, a Certificate of Authority to transact the business of insurance in the State of Alaska was issued to US INTERNATIONAL REINSURANCE COMPANY, domiciled in the State of New Hampshire.

WHEREAS, US INTERNATIONAL REINSURANCE COMPANY, has ceased writing any new or renewal business since 1992 and is in voluntary runoff.

WHEREAS, The New Hampshire Department of Insurance on March 3, 1997 placed US INTERNATIONAL REINSURANCE COMPANY under an Order of Supervision which continues to the present.

WHEREAS, the Certificate of Authority issued to US INTERNATIONAL REINSURANCE COMPANY to transact the business of insurance in the State of Alaska was suspended on May 23, 1997 and that suspension continues to the present.

IT IS HEREBY ORDERED, pursuant to the provision of AS 21.09.150 (c) that Certificate of Authority No F- 1676 issued to US INTERNATIONAL REINSURANCE COMPANY to transact the business of insurance in the State of Alaska shall be suspended for a period of one year unless terminated sooner as permitted by statute. Pursuant to AS 21.09.160 (b), this suspension shall automatically suspend the authority of all its agents to act as agents in this state.

IT IS FURTHER ORDERED, that during the period of suspension, US

INTERNATIONAL REINSURANCE COMPANY shall not solicit or write
any new business in Alaska, but shall file the Annual Statement, pay fees and any
taxes due as provided by AS 21.09.170 (b).

IT IS FURTHER ORDERED that Certificate of Authority No. F- 1676
will continue to be held in safekeeping by US INTERNATIONAL
REINSURANCE COMPANY until such time as this Order of Suspension is
replaced by an Order of Revocation or the Certificate of Authority is surrendered.
