WHEREAS, a Certificate of Authority to transact the
business of insurance in the State of Alaska was issued to
FRONTIER INSURANCE COMPANY, domiciled in the State of New
York.

WHEREAS, the Supreme Court of New York, County of New
York, issued an Order of Rehabilitation dated October 15,
2001, appointing the Superintendent of Insurance of the
State of New York as Rehabilitator for **FRONTIER INSURANCE**
COMPANY. The company continues under the Order of

1 Rehabilitation to the present time.
2

3 **WHEREAS**, the Certificate of Authority of **FRONTIER**
4 **INSURANCE COMPANY** to transact the business of insurance in
5 the state of Alaska was suspended effective April 9, 2002,
6 for a period of one year.
7

8 **WHEREAS**, the 2001 Annual Statement of **FRONTIER**
9 **INSURANCE COMPANY** shows that surplus fails to meet the
10 requirements of AS 21.09.070.
11

12 **WHEREAS**, the Annual Statement as of December 31,
13 2002 for **FRONTIER INSURANCE COMPANY** was not filed as
14 per the requirements of AS 21.09.200 (a).
15

16 **WHEREAS**, **FRONTIER INSURANCE COMPANY** has failed to pay
17 the 2001 and 2002 continuation fee as required by AS
18 21.09.130 by the June 30 due date.
19

20 **IT IS HEREBY ORDERED**, pursuant to the provision of AS
21 21.09.140 that Certificate of Authority No. F-8054 issued
22 to **FRONTIER INSURANCE COMPANY** to transact the business of
23 insurance in the State of Alaska shall be suspended for a
24 period of one year unless terminated sooner as permitted by
25 statute. Pursuant to AS 21.09.160(b), this suspension
26 shall automatically suspend the authority of all its agents
27 to act as agents of **FRONTIER INSURANCE COMPANY** in this
28 state.

30 **IT IS FURTHER ORDERED**, that during the period of

suspension, **FRONTIER INSURANCE COMPANY** shall not solicit or write any new business in the State of Alaska, but shall file the Annual Statement, pay fees and any taxes due as provided by AS 21.09.170(b).

IT IS FURTHER ORDERED, that Certificate of Authority No. F-8054 will continue to be held in safekeeping by **FRONTIER INSURANCE COMPANY** until such time as this Order of Suspension is replaced by an Order of Revocation or the Certificate of Authority is surrendered.
