10 **IT IS HEREBY ORDERED**, pursuant to the provision of AS 21.09.140 (a)  
11 (2) that Certificate of Authority No F- 0551 issued to **ATLANTA**  
12 **INTERNATIONAL INSURANCE COMPANY** to transact the business of  
13 insurance in the State of Alaska shall be suspended for a period of one year unless  
14 terminated sooner as permitted by statute. Pursuant to AS 21.09.160 (b), this  
15 suspension shall automatically suspend the authority of all its agents to act as  
16 agents in this state.

20 **IT IS FURTHER ORDERED**, that during the period of suspension,  
21 **ATLANTA INTERNATIONAL INSURANCE COMPANY** shall not solicit or  
22 write any new business in Alaska, but shall file the Annual Statement, pay fees  
23 and any taxes due as provided by AS 21.09.170 (b).

26 **IT IS FURTHER ORDERED** that Certificate of Authority No. F- 0551  
27 will continue to be held in safekeeping by **ATLANTA INTERNATIONAL**
