FRONTIER INSURANCE COMPANY. The company continues under the Order of Rehabilitation to the present time.

WHEREAS, the Certificate of Authority of **FRONTIER INSURANCE COMPANY** to transact the business of insurance in the State of Alaska was suspended effective April 9, 2002, for a period of one year and that suspension has continued to the present.

WHEREAS, FRONTIER INSURANCE COMPANY, has failed to pay the 2003 continuation fee as required by AS 21.09.130 (b) by the June 30 due date.

WHEREAS, the last annual statement received for **FRONTIER INSURANCE COMPANY** being the 2003 Annual Statement, showed that the company failed to meet the minimum Capital and Surplus requirement of AS 21.09.070 for the lines of insurance authorized.

WHEREAS, FRONTIER INSURANCE COMPANY's Certificate of Authority has been revoked in the states of Ohio, Tennessee, Washington, Wyoming, Missouri, Georgia and Oklahoma.

IT IS HEREBY ORDERED, pursuant to the provision of AS 21.09.140 (a) (2) that Certificate of Authority No F- 8054 issued to **FRONTIER INSURANCE COMPANY** to transact the business of insurance in the State of Alaska shall be revoked. Pursuant to AS 21.09.160 (b), this revocation shall automatically revoke the authority of all its agents to act as agents of **FRONTIER INSURANCE COMPANY** in this state.
