WHEREAS, the 2003 Annual Statement of shows that **NATIONAL HEALTH INSURANCE COMPANY** fails to meet the capital and surplus requirements of AS 21.09.070.

IT IS HEREBY ORDERED, pursuant to the provision of AS 21.09.140 (a) (2) that Certificate of Authority No. F-1403 issued to **NATIONAL HEALTH INSURANCE COMPANY** to transact the business of insurance in the State of Alaska shall be suspended for a period of one year unless terminated sooner as permitted by statute. Pursuant to AS 21.09.160 (b), this suspension shall automatically suspend the authority of all of its agents to act as agents of **NATIONAL HEALTH INSURANCE COMPANY** in this state.

IT IS FURTHER ORDERED, that during the period of the suspension, **NATIONAL HEALTH INSURANCE COMPANY** shall not solicit or write any new business in the State of Alaska but shall file its Annual Statement, pay fees and any taxes due as provided by AS 21.09.170(b).


IT IS FURTHER ORDERED, that Certificate of Authority No. F-1403 will continue to be held in safekeeping by **NATIONAL HEALTH**
