WHEREAS, the last annual statement received for NORTHWESTERN NATIONAL INSURANCE COMPANY OF MILWAUKEE, WISCONSIN being the 2003 Annual Statement shows that the company fails to meet the minimum capital and surplus requirements of AS 21.09.070 for the kinds of insurance authorized.

WHEREAS, AS 21.09.140 (a) (2) states that the director shall suspend or revoke an insurer's Certificate of Authority if the insurer no longer meets the requirements for the authority granted, on account of the insurer becoming impaired or insolvent or otherwise.

IT IS HEREBY ORDERED, pursuant to the provision of AS 21.09.140 (a) (2) that Certificate of Authority No. F- 0652 issued to NORTHWESTERN NATIONAL INSURANCE COMPANY OF MILWAUKEE, WISCONSIN to transact the business of insurance in the State of Alaska shall be revoked.

Pursuant to AS 21.09.160 (b), this revocation shall automatically revoke the authority of all its agents to act as agents for it in this state.

IT IS FURTHER ORDERED, that Certificate of Authority No. F-0652
held in safekeeping by NORTHWESTERN NATIONAL INSURANCE
COMPANY OF MILWAUKEE, WISCONSIN shall be returned to the Alaska
Division of Insurance by January 18, 2005
