That suspension has continued in effect until the present.

WHEREAS, VESTA INSURANCE CORPORATION has failed to file the 2006 and subsequent Annual Statements by the due date as required by AS 21.09.200 (a).

WHEREAS, VESTA INSURANCE CORPORATION has failed to pay the 2007, 2008, 2009, and 2010 continuation fees by the June 30 due date as required by AS 21.09.130(a).

WHEREAS, Certificate of Authority No. F-8023 issued to VESTA

INSURANCE CORPORATION to transact the business of insurance in the

State of Alaska will expire on August 2, 2011 as there has been no satisfactory

evidence presented that VESTA INSURANCE CORPORATION has been

removed from said Order of Rehabilitation as required by AS 21.09.070(d) within

five years after the date of suspension. Pursuant to AS 21.09.160 (b), this

expiration shall automatically revoke the authority of all its agents to act as agents of **VESTA INSURANCE CORPORATION** in this state.

IT **IS HEREBY ORDERED** that Certificate of Authority No. F-8023 held in safekeeping by **VESTA INSURANCE CORPORATION** shall be returned to the Alaska Division of Insurance by September 9, 2011.
