WHEREAS, a Certificate of Authority to transact business of insurance in

1 **WHEREAS**, the Quarterly Statement for the period ending March 31, 2008,
2 shows that **LINCOLN MEMORIAL LIFE INSURANCE COMPANY** fails to
3 meet the capital and surplus requirements of AS 21.09.070 for the kinds of
4 insurance authorized.

7 **IT IS HEREBY ORDERED**, pursuant to the provision of AS 21.09.140 (a)
8 (3) that Certificate of Authority No. F-729, issued to **LINCOLN MEMORIAL**
9 **LIFE INSURANCE COMPANY** to transact the business of insurance in the
10 State of Alaska shall be suspended until such time as it has returned to full
11 compliance with Alaska Statutes unless terminated sooner as permitted by statute.
12 Pursuant to AS 21.09.160 (b), this suspension shall automatically suspend the
13 authority of all of its agents to act as agents of **LINCOLN MEMORIAL LIFE**
14 **INSURANCE COMPANY** in this state.

18 **IT IS FURTHER ORDERED**, that during the period of suspension,
19 **LINCOLN MEMORIAL LIFE INSURANCE COMPANY** shall not solicit or
20 write new business in the State of Alaska, but shall file the annual statement, pay
21 fees and any taxes due as provided by AS 21.09.170(b).


