6 **WHEREAS**, the Annual Statement of **TRIAD GUARANTY**
7 **INSURANCE CORPORATION** for the period ending December 31, 2008,
8 shows that the company experienced a decline in policyholder surplus of more
9 than fifty percent.

12 **WHEREAS**, **TRIAD GUARANTY INSURANCE CORPORATION** is
13 deemed to be in an impaired condition as defined in AS 21.90.900

16 **IT IS HEREBY ORDERED**, pursuant to the provisions of AS 21.09.175
17 and 3 ACC 21.520, that **TRIAD GUARANTY INSURANCE**
18 **CORPORATION** shall cease the writing of new business in the State of Alaska
19 until such time as it has returned to full compliance with Alaska Statutes unless
20 terminated sooner as permitted by statute.


