Pursuant to AS 21.09.160 (b), this suspension shall continue to suspend the authority of all of its agents to act as agents of FOX INSURANCE COMPANY in this state.

IT IS FURTHER ORDERED that during the period of suspension FOX INSURANCE COMPANY shall not solicit or write new business in the State of Alaska but shall file the annual statement, pay fees and any taxes due as provided by AS 21.09.170(b).

IT IS FURTHER ORDERED, that Certificate of Authority No. F-10905 will continue to be held in safekeeping by FOX INSURANCE COMPANY until
