12 of the State of Alaska under AS 21.09.070 within five years of the date of

16 **IT IS HEREBY ORDERED**, pursuant to the provisions of AS 21.09.170
17 (d), that Certificate of Authority No. F-1365 issued to **CIFG ASSURANCE**
18 **NORTH AMERICA, INC.** to transact the business of insurance in the State of
19 Alaska expired December 17, 2013. Pursuant to AS 21.09.160 (b), this expiration
20 shall automatically revoke the authority of all agents to act as agents of **CIFG**
21 **ASSURANCE NORTH AMERICA, INC.** in this state.
