1                   **WHEREAS, AMERICAN MEDICAL and LIFE INSURANCE**  
2                   **COMPANY's** Certificate of Authority was suspended in the State of Oregon on  
3                   March 19, 2014 for failure to maintain minimum capital and surplus.

6                   **IT IS HEREBY ORDERED**, pursuant to the provisions of AS 21.09.140  
7                   (a) (2), that Certificate of Authority No. F-10628 issued to **AMERICAN**  
8                   **MEDICAL and LIFE INSURANCE COMPANY** to transact the business of  
9                   insurance in the State of Alaska shall be suspended until such time as it has  
10                  returned to full compliance with Alaska Statutes unless terminated sooner as  
11                  permitted by statute. Pursuant to AS 21.09.160(b), this suspension shall  
12                  automatically suspend the authority of all of its agents to act as agents of  
13                  **AMERICAN MEDICAL and LIFE INSURANCE COMPANY. IT IS**  
14                  **FURTHER ORDERED** that during this period of suspension, **AMERICAN**  
15                  **MEDICAL and LIFE INSURANCE COMPANY** shall continue to file the  
16                  annual statement and pay fees and any taxes due as provided by AS  
17                  21.09.170(b).


22                  **IT IS FURTHER ORDERED** that Certificate of Authority No. F-10628
