WHEREAS, a Certificate of Authority to transact the business of insurance
in the State of Alaska was issued to **CASTLEPOINT NATIONAL**
INSURANCE COMPANY, domiciled in the State of California.

WHEREAS, on July 28, 2016, the Superior Court of the State of California
City and County of San Francisco placed **CASTLEPOINT NATIONAL**
INSURANCE COMPANY under an Order of Conservation and Liquidation
Plan naming Insurance Commissioner, Dave Jones as Conservator, as it had
reasonable cause to believe that further transaction of business by the company
would be hazardous to its policyholders, creditors and the public good.

WHEREAS, CASTLEPOINT NATIONAL INSURANCE COMPANY
has failed to file the 2015 Annual Statement by the March 2016 due date as
required by AS 21.09.200(a).

IT IS HEREBY ORDERED, pursuant to the provisions of AS 21.09.140
(a) (2) and AS 21.09.200(e), that Certificate of Authority No. F-1476 issued to
CASTLEPOINT NATIONAL INSURANCE COMPANY to transact the
business of insurance in the State of Alaska shall be suspended until such time as
it has returned to full compliance with Alaska Statutes unless terminated sooner
as permitted by statute. Pursuant to AS 21.09.160 (b), this suspension shall
automatically suspend the authority of all of its agents to act as agents of
CASTLEPOINT NATIONAL INSURANCE COMPANY.


IT IS FURTHER ORDERED that during this period of suspension,
CASTLEPOINT NATIONAL INSURANCE COMPANY shall continue to
file the annual statement and pay fees and any taxes due as provided by AS
21.09.170(b) and to service its outstanding business in force in this state.

IT IS FURTHER ORDERED that Certificate of Authority No. F-1476
will continue to be held in safekeeping by **CASTLEPOINT NATIONAL**
INSURANCE COMPANY until such time as this order is replaced by an Order
of Revocation, the Certificate of Authority is surrendered or the Certificate of
Authority expires.
