The director, under authority of AS 21.06.180 and AS 21.22.030, gives notice that the Division of Insurance is considering a plan of acquisition of control of Sunderland Marine Mutual Insurance Company, Ltd, a United Kingdom insurer, parent of Sunderland Marine Mutual Insurance Company (US Branch), Ltd, an Alaska domiciled marine insurer, by North of England Protection & Indemnity Association, Ltd, a United Kingdom corporate association.

The division will hold a hearing in the 15<sup>th</sup> floor conference room, Suite 1560, Atwood Building, 550 West Seventh Avenue, Anchorage Alaska at 9:00 a.m., Alaska Standard Time, Wednesday, February 12, 2014. Any interested person may present oral or written statements or arguments relevant to the director's consideration of the proposed action. The hearing will be held from 9:00 a.m. to 10:00 a.m. and may be extended to accommodate those present before 10:00 a.m. who do not have an opportunity to testify.
