### ANNUAL REPORT OF ALASKA MORTGAGE BROKER/LENDER

for the year ending December 31, 2017

The form shall be emailed to mortgagelending@alaska.gov on or before March 15, 2018.

Pursuant to Alaska Statutes Section 06.60.100 every mortgage licensee under the Alaska Secure and Fair Enforcement Act of 2010 (Alaska SAFE Act) shall file an annual report, under oath or on affirmation, with the Commissioner of the Department of Commerce, Community, and Economic Development. Reports covering operations during the preceding calendar year, January 1, 2017 through December 31, 2017, are to be filed on or before **March 15, 2018**, and are to include affirmation of the 4th Quarter Mortgage Call Report NMLS submission.

The Statute does not provide for an extension of the filing period. A mortgage licensee who fails to file a report may be subject to a civil penalty of \$25 for each day's failure to file the report, an additional civil penalty of up to \$10,000 and may result in the commencement of an administrative action against the mortgage licensee.
