AGREEMENT

This Agreement is between the Department of Commerce, Community, and Economic Development, Division of Banking and Securities ("Division") and Robinhood Crypto, LLC ("RHC").

On or about July 11, 2018, the Division received an application from RHC for a money transmission license under Alaska Statute (AS) 06.55.103. The Division's review of this application disclosed that RHC was applying for an Alaska money transmission license in order to provide "traditional" money transmission of fiat currency, as well as the transmission of virtual currency.

RHC is aware the Division is unable under current state law to license RHC to transmit virtual currency, yet wants to pursue a money transmission license regardless of this limitation. The Division is willing to issue RHC an Alaska money transmission license for transmission using fiat currency.

On the effective date of this agreement, the Division will issue RHC's Alaska money transmission license, limited as follows:

a. RHC shall not use its Alaska money transmission license to transmit virtual

currency;

transmit virtual currency; 4 c.
