What's New

The division is contracting with ELSES, an affiliate owned by NCEES, to begin administration of the FE/PE and FS/PS exams beginning with the October 2006 administration.

Applicants will no longer pay exam fees to the division, but will pay these fees directly to ELSES.

Applicants will still apply to the AELS board and pay a \$50 nonrefundable application fee. AELS will notify ELSES of eligible candidates and candidates will then work with ELSES regarding payment and scheduling.

Other Updates

The board adopted a board policy to create a Board Committee Review plan whereby two board members will meet monthly with division investigators to determine merit and disposition of complaints.

CE for Architects:

Thom Lowther, Senior Director, Continuing Education, AIA Continuing Education, attended the February 2006 meeting to speak to the board regarding mandatory continuing education for architects.

Office of Administrative Hearings:

Chief Administrative Law Judge, Terry Thurbon, attended the February 2006 meeting to speak to the board regarding the changes to the administrative hearing process that became effective in July 2005.

Board Elections:

At its February 2006 meeting the board re-elected Ken Maynard as Chair and Mark Morris as Secretary, and elected Boyd Brownfield as Vice-Chair.

Applicant Files Reviewed

At its February 2006 meeting the board reviewed and approved or conditionally approved 105 applicants for registration by examination or comity. The board also approved 74 applicants for the FE exam. Eight applications were found to be incomplete and will be re-reviewed at the May 2006 meeting upon receipt of additional documentation.

AELS Deadlines/Exam Information

Effective immediately the deadline for "complete" applications for registration by comity and "complete" applications for the FE/PE and FS/PS exams will be receipt in the *Juneau Office* at least 10 days prior to the next board meeting. THERE WILL BE NO EXCEPTIONS TO THIS DEADLINE.

The next board meeting is tentatively scheduled for May 24-26 in Fairbanks. The meeting location will be at UAF, Butrovich Building, Board of Regents' Conference Room.
