# **AELS Quarterly Board Meeting**

The Board of Registration for Architects, Engineers, and Land Surveyors (AELS Board) held a quarterly board meeting on February 7-8, 2008 in Juneau.

Board members in attendance were: Boyd Brownfield, PE, Chair; Craig Fredeen, PE, Vice-Chair, Mark Morris, PE, Secretary, Clifford Baker, PS, Charles Leet, PE, Daniel Walsh, PE, Kenneth Maynard, FAIA, Richard Heieren, PS, and Burdett Lent, LA.

Harley Hightower, FAIA, had been excused from the meeting.

The public member seat on the board is currently vacant.

# **Disciplinary Actions Taken**

There were no disciplinary actions taken at this meeting.

#### **Regulations**

The board re-adopted the following regulations after review by the Department of Law:

- 12 AAC 36.040(c) exempt the AKLS exam from the 5x5 rule.
- 12 AAC 36.061 adopt the 2007-2008 NCARB Education Standard.
- Minor changes to the continuing education regulations in 12 AAC 36.500-.550.
- 12 AAC 36.910 a regulation giving the board authority to recommend to the Governor a board member be removed if that member has three or more unexcused absences in a 24month period.

The board did not adopt the proposed regulations to require a jurisprudence exam for all registrants and is waiting an opinion from the Dept. of Law.

The board re-approved the following regulations for public notice as the newspaper failed to publish them:

- 12 AAC 36.195 site adaptation/field alterations
- 12 AAC 36.090 waiver of FE exam for Canadian registered engineers

# **New Regulation Projects for Board Review**

A new regulation project was initiated to require architect applicants by examination to complete the Intern Development Program (IDP) prior to sitting for the Building Planning (BP) and Building Technology (BT) sections of the Architect Registration Exam (ARE), Version 3.1 and the Building Design & Construction Systems (BD) and Schematic Design (SD) sections of the ARE, Version 4.0.

# Legislation

SB 263 was introduced on February 8, 2008 which, if passed, will allow a chemical or petroleum engineer to fill the mining engineer seat on the board if a mining engineer is not available and (AS 08.48.011) and an exemption from registration for persons certified through NICET (As 08.48.331(13)).

Not included in the bill was language to change the board composition by making the landscape architect seat a permanent voting seat. The board hopes to introduce a stand-alone bill for this legislation next session.

# **Applicant Files Reviewed**

The board reviewed 190 applications for registration and examination:

- 153 applications for registration by exam and comity were approved.
- 29 applications for registration by comity and exam were conditionally approved.
- 6 applications were found to be incomplete and will be reviewed at the next meeting.
- 2 applications were denied.

#### **Action Items - Motions**

- A motion failed that would have allowed students with 75% completion of a BSE to sit for the FE exam. However, the four BSE students that board staff had approved before realizing they were in a BSE program will be allowed to sit for the April FE exam.
- Motion passed to approve a new Arctic Course being offered by UAA – ES AC 031.

- Motion passed to authorize Mark Morris to research revising the regulations pertaining to the number of times an exam applicant can sit for the exam, and requiring course work or a meeting with the board when the exam has been failed a certain number of times; and further authorizing Morris to look at the requirements for work experience, type of experience, and definitions of experience as they apply to the PE exam qualification.
- Motion passed to adopt the committee's recommendation for amendments to 12 AAC 36.062 and .063. and approve for a regulation project.
- Motion passed to retain the current officers of the board for another year; Brownfield, Chair; Fredeen, Vice-Chair; and Morris, Secretary.
- Motion passed for Heieren to bring to the next meeting a draft of board bylaws for review by the board as a whole.
- Motion failed wherein the board was asked to review an application outside of a scheduled meeting.

The next board meeting is tentatively scheduled for May 29-30, 2008 in Fairbanks. The meeting will be held in the Butrovich Building, Board of Regents Conference Room, UAF. The deadline for comity and examination applications is receipt in the Juneau office 10 days prior to the meeting.
