**MINUTES OF SPECIAL
TELECONFERENCE MEETING**

Call to Order

Agenda Item In the Matter of Case Nos. 2856-08-001 and 2806-09-005

Gayle Horetski presented a signed voluntary surrender agreement to the Board. She noted that it was a standard surrender agreement regarding a license that had been summarily suspended on April 15, 2011, and will resolve the pending appeal by the licensee. He would have the right, under the Administrative Procedures Act, to seek reinstatement of the license, but must wait at least a year to apply, and must prove to the Board that he is competent to resume practice; the Board would have the authority to approve or deny any reinstatement. It was also reported that the Respondent is under a Board order in the State of Washington regarding the same or similar issues, and appears to be in compliance with that order.

Upon a motion duly made by Ms. Millar, seconded by Mr. Tauriainen, and approved by roll call vote, it was:

RESOLVED to accept the voluntary surrender agreement signed by Jesse T. Fenger.
