SURRENDER OF LICENSE

Case # 2012-000301

I, Ronald H. Engberson, voluntarily surrender Alaska Board of Pharmacy License #1778, which was first issued to me on July 17, 2008 and lapsed on June 30, 2012.

I am permanently surrendering my license at this time with the understanding that the Division of Corporations, Business and Professional Licensing has completed an investigation under case number 2012-000301, on behalf of the Alaska State Board of Pharmacy (Board), which resulted in the criminal charges I plead guilty to on March 11, 2013. The charge was a felony offense which is in violation of AS 8.80.261(a)(4), 12 AAC 52.075 and 12 AAC 52.920(a)(15)(b)(3). The charge was related to my possessing, writing, and filling forged prescriptions using the prescription pad of a Physicians Assistant (PA) located in Idaho and dispensing controlled substances for my own use.

I understand as a result of this surrender, I cannot practice as a Pharmacist in the State of Alaska and will not be able to do so until I have the approval of the Alaska State Board of Pharmacy.

I am surrendering my license of my own free will and no promises or threats have been made to me by anyone to make me sign this document.
